ORDER

In pursuance of Hon'ble Supreme Court of India order dated 22.09.2006 in WP (Civil) No. 310/1996 (Prakash Singh and Others vs UoI and others), order dated 03.07.2018 in IA No. 25307/2018 and order dated 13.03.2019 in IA No. 24616/2019 and as per recommendation of the Empanelment Committee constituted by the Union Public Service Commission for this purpose, Shri Umesh Mishra, IPS (RR:1989) (DoB: 01.05.1964) was appointed to the post of Director General of Police (Head of Police Force), Rajasthan, Jaipur vide this department's order No. F.5(15)Pers/A-I/91 dated 27.10.2022 for a period of two years vice Shri Mohan Lal Lather, IPS upon his retirement on 03.11.2022.
